ICCWC provides targeted capacity building, operational support and services to authorities across the entire criminal justice system to better deter, detect, detain and dismantle criminal networks involved in wildlife crime.

The **ICCWC Menu of Services** provides an indicative list of the training courses, tools and services available through ICCWC. These can subject to availability of resources be implemented in countries and regions across the globe based on priorities and needs identified. The activities listed in the menu of services are not exhaustive and tailored activities and interventions can also be developed where required. ICCWC pursue delivery of activities in an evidence based manner, drawing upon implementation results from using tools such as the *ICCWC Wildlife and Forest Crime Analytic Toolkit* and the *ICCWC Indicator Framework for Combating Wildlife and Forest Crime*, needs identified during law enforcement operations, as well as knowledge gained through the other multiple and diverse activities delivered by ICCWC globally.

Established in 2010, ICCWC is a unique and powerful partnership of five inter-governmental organizations working together against wildlife crime. It is made up of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) Secretariat, INTERPOL, the United Nations Office on Drugs and Crime (UNODC), the World Bank Group (WBG) and the World Customs Organization (WCO).

The Menu of Services is structured against seven headings as shown below, in accordance with the type of activities that can be delivered or supported by ICCWC.

-  **Wildlife crime scene management and forensics**
-  **Wildlife crime scene investigations**
-  **Border control**
-  **Cross-border, regional and international cooperation**
-  **Combating corruption and anti-money laundering**
-  **Judiciary and prosecution**
-  **Cross-cutting**

An activity delivered by ICCWC is normally led by one “lead” ICCWC partner. This partner takes responsibility for implementation of the activity, whilst closely coordinating and collaborating with other relevant ICCWC partners and stakeholders in its delivery. In some instances, when circumstances require, multiple ICCWC partner organizations can also jointly “lead” an activity, taking collective responsibility for its implementation.
